**Subject:- Approval of landing places and specifying limits of Customs Area for the purpose of unloading/loading of import goods/goods for re-export.**

In exercise of the powers conferred on me under Section 8 (a) of the Customs Act, 1962, I, Ved Prakash Shukla, Commissioner of Customs (Preventive) Commissionerate, Lucknow hereby notify the site of 11<sup>th</sup> DEFEXPO INIDA 2020, an international exhibition to be held at Sector 15, Vrindavan Yojna, Lucknow from 05.02.2020 to 09.02.2020(F/N) as approved Customs Area for the purpose of unloading, storage, handling, examination and exhibition of goods imported for DEFEXPO INDIA, 2020 and loading of imported goods for the purpose of re-export.

2 Further, by virtue of powers vested in me under Section 8(b) of the Customs Act, 1962, I hereby specify the limits of Customs Area comprising the above mentioned exhibition site at Sector 15, Vrindavan Yojna, Lucknow as specified in the site plan submitted by Addition General Manager (IMM), HAL, Lucknow vide his letter No. H.A.L.-A.D.L./I.I.M./DEFEXPO2020/1 dated 03.12.2019. The scheduled boundary limits based on the layout plan for DEFEXPO INDIA, 2020 site are as under:-


East Bounded by : Sector 14 Vrindavan Yojna
