Subject:- Conduct of online Examination under Regulation 6 of Customs Brokers Licensing Regulation, 2018 by the National Academy of Customs, Indirect Taxes and Narcotics (NACIN), Faridabad -Reg.

The written examination of Customs Brokers Licensing Examination, for the **Year 2023**, shall be conducted by NACIN in the Month of **March-2023** at the designated examination centers across India.

2. Complete application is to be submitted in person or by Registered/ Speed Post in Form-A (available in the CBLR, 2018) along with two passport size photos and self attested documents on citizenship (Aadhaar/ Passport/ Voter Card), educational qualification, financial viability, mobile number, e-mail id and other requirements along with the prescribed fee of **Rs.500/-** (Rupees five hundred only) to the Principal Commissioner/ Commissioner of Customs/Commissioner of Customs (Prev), having jurisdiction over the area where the applicant intends to carry on his business from **18.10.2022 to 18.11.2022 up to 06:00 PM**. Applications sent by post, in case received after the last date shall not be entertained.

3. The online written examination will be a Computer Based Exam with Multiple Choice Questions (MCQs) of **two and half hours (10:30 hrs to 13:00 hrs) duration**. Questions will be bilingual i.e. in English and Hindi. The pattern of the examination will be as follows:

No. of questions : 150

Marking scheme : +3 for each correct answer
-1 for each incorrect answer

Maximum marks : 450

Qualifying marks : 270 (60%)

4. The syllabus of examination is prescribed in Regulation 6(7) of the Customs Brokers Licensing Regulations, 2018, as amended. Those qualifying in the said examination will have to appear for oral examination in terms of Regulation 6 of the said Regulations.

5. The oral examination will be held during the second quarter of the calendar year 2023. **The pass percentage marks for qualifying in the oral examination will be 60%.**

6. Attention is invited to the Guidelines dated 29.08.2018 issued by Ministry of Social Justice and Empowerment, Department of Empowerment of Persons with Disabilities (Divyangjan) and circulated by CBIC vide letter dated 10.10.2018 pertaining to the persons with benchmark disability. It is hereby advised that eligible candidates meeting these criteria of benchmark disability and willing to avail the benefit of these guidelines should appropriately intimate about their eligibility and willingness so that necessary arrangements can be made by the exam conducting authority and its partner agencies.

7. A dummy question paper for the purpose of awareness of candidates will be made available on the CBIC and NACIN websites www.cbic.gov.in and www.nacin.gov.in under the icon/tab <GSTP/CBLR EXAM> from **February, 2023**. A link to download the admit card will also be provided therein. Admit card shall also be sent by e-mail to eligible applicants 12 days in advance before the date of examination. For convenience of candidates, other necessary details like list of centers, guidelines to the candidates, help desk, e-mail id. etc will also be made available under the said icon/ tab.
