

SUBJECT: Unavailability of correct bank account details of Some exporters, required for processing of IGST refund claims.

The attention of general trade is invited towards bank account related problems, owing to which processing of IGST refund claims arising from exports effected from different LCSs/Air Cargos of this Commissionerate, is being delayed.


2. In many cases of manual Shipping Bills for exports taken place after 1st July 2017, from erstwhile non EDI LCS/Air cargo, Bank account details of such exporters, are not available with respective custom offices LCS/Air Cargo. In many cases, refund claimed is stuck due to PFMS invalidation of bank Account details.

3. The Exporters, whose IGST refund claims are till date pending, are requested to contact the respective Land Customs Station (LCSs) by themselves or through their authorized representatives and in case of above mentioned account related problems, submit their correct bank account details and any other required data. Phone numbers and address of LCS/Air cargo and respective divisions are available at the website of Commissionerate- www.commissionercustomslucknow.gov.in
