

In continuation of Notification No. 01/2016-CUS (N.T.) dated 16.09.2016 issued by Commissioner, Customs & Central Excise, Kanpur and in exercise of the powers conferred upon me under Section 45(1) of the Customs Act, 1962, I, Ved Prakash Shukla, Commissioner of Customs (Preventive), Lucknow hereby extend custodianship to M/s. Kanpur logistics Park Pvt Ltd. ( hereinafter referred to as M/s KLPL), Custodian of ICD Panki, Kanpur to be the Custodian of the imported goods received in containers at rail linked Inland container depot at Panki, Kanpur until these are cleared for home consumption or are warehoused or transshipped in accordance with the provisions of Chapter VIII of the Customs Act, 1962. Likewise, the said M/s KLPL will be the Custodian of imported goods and export cargo brought into at rail linked Inland container depot at Panki, Kanpur for stuffing, accountal, Customs examination, transportation and safe delivery of Customs sealed containers for onward transshipment to the port of dispatch.

M/s KLPL, as the custodian of the goods meant for import and export would be required to comply with the provisions of Section 45(2) & (3) of the Customs Act, 1962 read with provisions contained in Handling of Cargo in Customs Area Regulations, 2009 and the Rules and Regulations made and instructions issued there under from time to time.


The appointment of custodianship is renewed for six months with effect from 27.06.2021 and subject to the satisfaction of the Commissioner of Customs, Lucknow. The Commissioner of Customs (Preventive), Lucknow, shall have the right to terminate the appointment at any time after assigning specific reasons and giving an opportunity to the Custodian to explain its case.
