



**NOTIFICATION NO. 03/2023  
DATED 31.05.2023**

**Subject: Customs Area Notification for Integrated Check Post, Rupaidiha, District-Bahraich, Uttar Pradesh.**

Whereas Nepalganj Road has been notified as Land Customs Station (LCS) under clauses (b) & (c) of Section 7 of the Customs Act, 1962 vide Notification no. 63/1994-Customs dated 21.11.1994 as amended.

2. And whereas in existing LCS, infrastructure has turned out to be inadequate to cater increased volume of Import and Export of cargo as well as passengers over the years, the Land port Authority of India (LPAI) has acquired & built Integrated Check Post (ICP) at Rupaidiha in nearby area of existing customs Area of LCS, Nepalganj Road.

3. Now, in exercise of the powers conferred on me under Section 8(a) of the Customs Act, 1962, I, Aarti Saxena, Commissioner of Customs, Customs (Preventive) Commissionerate, Lucknow hereby notify the area of Integrated Check Post, Rupaidiha as specified in Schedule 'A' below as additional Customs Area for unloading of imported goods and for loading of export goods subject to the strict observance of the provisions of the Customs Act, 1962 and other instructions issued in this behalf by the Government of India or Commissioner of Customs, Customs (Preventive), Commissionerate, Lucknow from time to time.
