Attention of all exporters, Customs Brokers and members of trade is brought to the notice of ROSL claims lying pending due to non validation of bank account details of the exporters by PFMS.

In this regard, it is to inform that unless the exporters' bank accounts are validated by PFMS, the shipping bills shall not be included in the final ROSL Scroll. Therefore, those exporters' whose bank account details are not validated by PFMS, are requested to approach the jurisdictional Customs Officer during the fortnightly campaign started from 31.05.2018 extending upto 14.06.2018, for correction in their bank account details and uploading of the same on EDI System for validation by PFMS
