

विषय : - 24x7 clearance- regarding.

Attention of all stakeholders is invited towards Board's Instruction No. 02/2020-Customs dated 20.02.2020 vide which it was directed to introduce 24x7 Customs clearance at all the Customs formations to address any congestion or delay or surge on account of the prevailing conditions due to outbreak of COVID-19.

2. In this regard, as the situation of COVID-19 pandemic is still prevailing and trade continues to face challenges therefore as a measure of facilitation, Board has decided to extend the facility of 24x7 Customs clearance at all the Customs formations till 30th June, 2020. However, designated Airports already under 24x7 operations shall continue to function even after 30th June, 2020.

3. Therefore, all concerned Incharge of Air Cargo Stations/ICDs falling under the jurisdiction of this Commissionerate are directed to deploy the sufficient number of officers on 24x7 basis. A record may also be maintained of the BEs/SBs filed beyond the normal office hours and report in this regard should be sent to this office immediately as and when asked.


