Subject:- Facilitation of clearance of import cargo due to delay arising due to outbreak of Corona Virus - reg.

Attention of Importers, Exporters, General Trade, Customs Brokers and all other stakeholders is invited to the Public Notice No. 06/2020 dated 25.03.2020 & Public Notice No. 07/2020 dated 14.04.2020 addendum dated 06.05.2020 to Public Notice No. 07/2020 dated 14.04.2020 issued by this office on the above cited subject. Kind attention is drawn to Order dated 17.05.2020 issued by the Ministry of Home Affairs, Government of India, New Delhi, whereby lockdown measures have been extended upto 31.05.2020 throughout the country.

2. In view of the above facts, Para 3 of Public Notice No. 07/2020 dated 14.04.2020 issued by the undersigned on the above subject, shall be read as under:

“3. In order to facilitate the trade, it has been decided in the public interest that those bills of entry filed for clearance of import consignment which have arrived at ICDs/LCSs/Airports on or after **20.03.2020 but on or before**

**31.05.2020, if filed late on or before 03.06.2020, will not attract any late fee charges."**

4. Public Notice No. 07/2020 dated 14.04.2020 is amended to the above extent.
5. The above decisions should be considered as standing order for the purpose of officers and staff posted under the jurisdiction of this Commissionerate.
6. Difficulty, if any, may be brought to the notice of this Office.
