Subject: Restoring the facility under Circular 17/2020 dated 03.04.2020 namely 'Measure to facilitate trade during lockdown period – Section 143 AA of the Customs Act, 1962'– Reg.

Attention of trade and industry and all other stakeholders is invited to the difficulties being faced in the ongoing lockdown/constraints imposed in different regions of India due to resurgence of Covid-19 pandemic in terms of requirements of bond in certain cases of Customs clearance.

2. Keeping in view of the difficulties being faced by the trade and industry and the importance of facilitating the Customs clearance process, the facility of acceptance of an undertaking in lieu of bond by Customs formations is restored from 08.05.2021 to 30.06.2021. Importer/Exporters availing this facility shall ensure that undertaking furnished in lieu of bond shall be duly replaced with a proper bond by 15.07.2021.

3. The terms and conditions underlined in Circular No. 17/2020-Cus., dated 03.04.2020 as amended by Circular No. 21/2020-Cus., dated 21.04.2020 issued by the Central Board of Indirect Taxes and Customs remain the same.
