

In continuation of Notification No. 02/1995 dated 24.05.1995 and in exercise of the powers conferred upon me under Section 45(1) of the Customs Act, 1962, I, Ved Prakash Shukla, Commissioner of Customs, Lucknow hereby extend custodianship to Central Warehousing Corporation, (hereinafter referred to as CWC), to be the Custodian of the imported goods landed at Inland Container Depot, Chakeri, Kanpur (herein after referred to as ICD, Chakeri, Kanpur) until they are cleared for home consumption or are warehoused or transhipped in accordance with the provisions of Chapter VIII of the Customs Act, 1962. Likewise, the said CWC will be the Custodian of imported goods and export cargo brought into the area at ICD, Chakeri, Kanpur for Customs examination, clearance and export and/or transshipment of goods to gateway port, subject to the condition that CWC, as the custodian of the goods meant for import and export would be required to comply with the provisions of Section 45(2) & (3) of the Customs Act, 1962 read with provisions contained in Handling of Cargo in Customs Area Regulations, 2009 and instructions issued there under from time to time.

The Custodian shall abide by all the Rules and Regulations under the Customs Act, 1962 read with the provisions of the Handling of Cargo in Customs Area Regulations, 2009 as amended.

The appointment of custodianship is being renewed for next five years i.e. upto 04.10.2025 and subject to the satisfaction of the Commissioner of Customs, Lucknow. The Commissioner of Customs, Lucknow, shall have the right to terminate the appointment at any time after assigning specific reasons and giving an opportunity to the Custodian to explain its case.
