Subject:-Stepping up of Preventive Vigilance Mechanism by the Jurisdictional CBIC Field Formations during General Elections to the Legislative Assemblies of Goa, Manipur, Punjab, Uttar Pradesh and Uttarakhand and Bye-election to 03 PCs and 30 ACs in 15 States/UT-Reg.

In order to follow the instructions dated 20.10.2021 (copy attached) on the above mentioned subject issued by the CBIC New Delhi, **NAKAS (Checking Points)** to be established on the following Indo-Nepal Border, the following officers are deputed for the Checking at NAKAS in light of above said instructions.

As you are aware that general legislative Assesembly Election are forthcoming in a couple of weeks in the Jurisdiction of our Commissionerate viz., **Uttar Pradesh and Uttarakhand**. In view of the above you are directed to go through the enclosed letter which is self explanatory and closely monitor the directions of Election Commission of India especially in detecting smuggled / illicit goods, identification of warehouse used to stock the goods for distribution to lure the voters, cash movement etc and also sharing of information to and from other enforcement agencies / department who are shouldering their responsibility in such detections in the elections.

A daily report in respect of NAKABANDI held, transit checks of vehicle conducted on roads, verification and stock taking of Customs bonded warehouses, illicit currency, liquor, gold, Drugs FICN, NDPS Items, undeclared cash in huge quantity, duration of Nakabandi, place where Nakabandi has been made and contraband goods (as per the items enclosed in the letters) detected / seized may please be sent to the **Nodal Officers (Shri Ajay Kumar Mishra, ADC Customs (P) HQ Lucknow)** on daily basis in the proforma attached. **Contact no. of Nodal Officer is 9619807711.**

It will the responsibility of the team in-charge /superintendent to be vigilant with his team and follow the protocol while dealing with VIPs/MPs and MLAs and with the general public so that no complaints of any misbehavior / extortion etc is received at this end. Where need be for search of a lady or her belongings the same should be done by a lady officer or a lady who agrees for such search and a punchnama with video recording should be made on the spot.
